99.5 THE WOLF'S "DECEMBER 16-20, 2019: NHL WINTER CLASSIC ® WOLF 4-PACK" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained at the offices of radio station KPLX-FM ("Station"), owned and operated by Radio Metroplex, LLC., 3090 Olive Street, Suite 400, Dallas, TX 75219, during normal business hours Monday through Friday or by sending a self-addressed, stamped envelope to the above address. **99.5 The Wolf's "December 16-20, 2019: NHL Winter Classic® Wolf 4-Pack" Contest** (the "Contest") substantially as described in these rules, and by participating, each participant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. The winning caller number, as announced at the time the cue-to call is given, to the Station, as determined by the Station in its sole discretion, will be given the prize announced, as detailed below (subject to verification of eligibility and compliance with the terms of these rules). Failure to respond to the initial verification contact within three (3) days of notification will result in disqualification.
