99.5 THE WOLF'S "DIERKS BENTLEY: MOUNTAIN HIGH TOUR – 7.9-7.13 GIVEAWAYS" CONTEST OFFICIAL RULES

The Station will conduct the **99.5** The Wolf's "Dierks Bentley: Mountain High Tour – **7.9-7.13** Giveaways" Contest (the "Contest") substantially as described in these rules, and by participating, each participant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. - 3. **How to Enter.** Listen to the Station every weekday from 7:00am CT through 7:00pm CT during the Contest Period. When the Station plays the "cue-to-call" sounder listeners should call the Station at 888-787-1995. The cue to call will sound weekdays at approximately 7:08am, 11:08am, 3:08pm, and 4:08pm giving listeners up to four (4) opportunities to win each day. The winning caller number as announced at the time of the cue to call to the Station, as determined by the Station in its sole discretion, may be awarded the prize announced, as detailed below (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. *Time Delay Between Over-the-Air Analog Signal and Internet Broadcast:* Due to the time delay that exists between the Station's analog over-the-air signal and the Station's online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station's analog over-the-air signal. As a result, the odds of an online listener entering this Contest on-air may be diminished.
- 4. Verification of Potential Winner.
