99.5 THE WOLF'S "KOE WETZEL AT BILLY BOB'S TICKET GIVEAWAYS (6/4-6/8 & 6/10)" CONTEST OFFICIAL RULES

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. When the Station plays the "cue-to-call" sounder, weekdays at approximately 8:08pm and 10:08pm and Sunday at approximately 6:08pm and 7:08pm, listeners should call the Station at 888-787-1995. The winning caller number as announced at the time of the cue to call to the Station, as determined by the Station in its sole discretion, may be awarded the prize announced, as detailed below (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest. *Time Delay Between Over-the-Air Analog Signal and Internet Broadcast:* Due to the time delay that exists between the Station's analog over-the-air signal and the Station's online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station's analog over-the-air signal.
