99.5 THE WOLF'S "LAST CHANCE THE BANDWAGON TOUR TICKETS" CONTEST OFFICIAL RULES

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility.  - (i) <u>On-Air</u>: Listen to the Station weekdays from 7:00am CT through 7:00pm CT during the Contest Period. When the Station plays the "cue-to-call" sounder, listeners should call the Station at 888-787-1995. The cue-to-call will sound weekdays at approximately 9:08am, 11:08am, 3:08pm & 4:08pm giving listeners up to four (4) opportunities to win the prize. The winning caller number, as determined by the Station in its sole discretion, will win the daily prize and be entered to win the grand prize. <u>Time Delay Between Over-the-Air Analog Signal and Internet Broadcast</u>: Due to the time delay that exists between the Station's analog over-the-air signal and the Station's online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station's analog over-the-air signal. As a result, the odds of an online listener entering this Contest on-air may be diminished.
- 4. Verification of Potential Winner.
