99.5 THE WOLF'S "SONG OF THE DAY: DISNEY CRUISE LINE GETAWAY" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained at the offices of radio station KPLX-FM ("Station"), owned and operated by Cumulus Media Holdings Inc. or one of its subsidiary companies, 3090 Olive Street, Suite 400, Dallas, TX 75219, during normal business hours Monday through Friday or by sending a self-addressed, stamped envelope to the above address.

After the announcement, listen for the Song of the Day to play up to two (2) times that day between 8:08 a.m., CT 9:59 a.m. CT and 4:08 p.m. CT and 6:59 p.m. CT. Once the song begins to play, listeners should call the Station at 888-787-1995. Caller ninety-nine (99) to the Station, as determined by the Station in its sole discretion, will win the Qualifying Prize and be entered to win the Grand Prize. <u>Time Delay Between Over-the-Air Analog Signal and Internet Broadcast</u>: Due to the time delay that exists between the Station's analog over-the-air signal and the Station's online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station's analog over-the-air signal.
