99.5 THE WOLF'S "JASON ALDEAN: HIGH NOON NEON TOUR LAST CHANCE TO WIN" CONTEST OFFICIAL RULES

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. The cue to call will sound weekdays at approximately 7:08am, 11:08am, 3:08pm, and 4:08pm giving listeners up to four (4) opportunities to win each day; and the cue to call will sound Tuesday at approximately eight minutes after every hour between 7:00am CT and 7:00pm CT giving listeners up to twelve (12) opportunities to win on Tuesday. The winning caller number as announced at the time of the cue to call to the Station, as determined by the Station in its sole discretion, may be awarded the prize announced, as detailed below (subject to verification of eligibility and compliance with the terms of these rules).
