99.5 THE WOLF'S "JANUARY 20-24, 2020: LISTEN TO WIN MARDI GRAS TEXAS STYLE! TICKETS" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained at the offices of radio station KPLX-FM ("Station"), owned and operated by Radio Metroplex, LLC., 3090 Nowitzki Way, Suite 400, Dallas, TX 75219, during normal business hours Monday through Friday or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the **99.5 The Wolf's "January 20-24, 2020: Listen to Win Mardi Gras** *Texas Style!* **Tickets"** Contest (the "Contest") substantially as described in these rules, and by participating, each participant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. When the Station plays the "cue-to-call" sounder, or announces the "cue-to-call", listeners should call the Station at 888-787-1995. The winning caller number to the Station, as determined by the Station in its sole discretion, will be given the prize announced, as detailed below (subject to verification of eligibility and compliance with the terms of these rules). Listeners will have up to four (4) opportunities to call in to win each day of the Contest Period. The "cue-to-call" will play at approximately 10:17am, 12:17pm, 3:17m & 5:17pm on Monday, January 20, 2020 and at approximately 7:17am, 12:17pm, 3:17pm & 5:17pm Tuesday, January 21, 2020 through Friday, January 24, 2020. Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. *Time Delay Between Over-the-Air Analog Signal and Internet Broadcast:* Due to the time delay that exists between the Station's analog over-the-air signal and the Station's online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station's analog over-the-air signal. As a result, the odds of an online listener entering this Contest on-air may be diminished.

The winning caller will be contacted within one (1) business day using the email address and/or telephone number provided with

7. Entry Conditions and Release.
