99.5 THE WOLF'S "KENNY CHESNEY CANCELED CONCERT WEEKEND" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained at the offices of radio station KPLX-FM ("Station"), owned and operated by Radio Metroplex, LLC. ,3090 Nowitzki Way, Suite 400, Dallas, TX 75219, during normal business hours Monday through Friday or by sending a self-addressed, stamped envelope to the above address.
