#### 99.5 THE WOLF'S "PAPA JOHN'S DALLAS COWBOYS TICKETS" CONTEST OFFICIAL RULES

The Station will conduct the **99.5 The Wolf's "PAPA JOHN'S DALLAS COWBOYS TICKETS"** Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

- 1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.
- 2. Eligibility. At or around 8:40am CT each 4. weekday (each, a "Selection Day"), when the Station plays the cue-to-call (each, the "Cue-to-Call"), listeners must call the Station at 888-787-1995. Caller nine (9), or any other caller number announced at the time of the Cue-to-Call to the Station, as determined by the Station in its sole discretion. The Caller will be asked a trivia question. If the caller correctly answers the question asked, the caller will be the winner for that Selection Day after providing the Station the winning listener's name and phone number, subject to verification and compliance with these Contest Rules. If the caller doe not correctly answer the question asked, the caller will not be the winner and the Station will take the next caller and ask that caller the same question. This process will continue until a caller correctly answers the trivia question asked for that Selection Day. All entries may be played on the air. Time Delay Between Over-the-Air Analog Signal and Internet Broadcast: Due to the time delay that exists between the Station's analog over-the-air signal and the Station's online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station's analog over-the-air signal.
