99.5 THE WOLF'S "KING GEORGE STRAIT" CONTEST OFFICIAL RULES

The Station will conduct the **99.5 The Wolf's "King George Strait"** Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

- 1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.
 - Eligibility. For example, when the station plays "Check Yes Or No" between 6:00am and 10:00am during the contest period, entrants must text, "Check Yes Or No", spelled correctly, to 888-787-1995. All entries must be received by 10:00am CT on August 18, 2023, to be eligible for a chance to win a prize. Station's decisions as to the administration and operation of the Contest and the selection of the potential winners are final and binding in all matters related to the Contest. Failure to verify winner's eligibility may result in disqualification and forfeiture of the prize. Unclaimed prizes may not be awarded. Message and data rates may apply. Failure to respond to the initial verification contact within three (3) days of notification or failure to claim the prize within three (3) days of verification as a winner will result in disqualification and forfeiture of the prize.
