99.5 THE WOLF'S "TURN IT UP FOR TEXAS – DFW HIGH SCHOOL MARCHING BAND" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained by contacting radio station KPLX-FM ("Station"), 3090 Nowitzki Way - Suite 400, Dallas, TX 75219, during available business hours Monday through Friday, on the Station website www.995thewolf.com, or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the **99.5 The Wolf's "Turn It Up For Texas – DFW High School Marching Band"** Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. This Contest is open only to legal U.S. residents of the Station's Designated Market Area ("DMA") as defined by Nielsen Audio, age eighteen (18) years or older at the time of entry with a valid Social Security number, who have not won a prize from the Station in the last 30 days or a prize valued at \$500 and whose immediate family members or household members have not won a prize from the Station in the last 30 days. Facebook, Instagram, and X: Entrants must:

- (a) Post a video of their high school marching band performing to their personal Facebook, Instagram, or X account during the Contest Period;
- (b) Tag the following accounts in the post: @995TheWolfDFW, @Kroger, and @GoodDayFox; and
- (c) Include in the caption: #TurnItUpForTexas.

Any entry comments that are indecent, lewd, offensive, defamatory, contain profanities, or are in any way in bad taste or contain material that may infringe or violate any laws or anyone's rights, as determined in the sole discretion of the Station, may be disqualified. Entry comments that are removed and/or blocked by Station and/or by Facebook, Instagram, or X will be deemed not entered in the Contest.

This Contest is in no way sponsored, endorsed, administered by, or associated with Facebook, Instagram, or X. By submission of an entry, an entrant releases Facebook, Instagram, and X from

any responsibility or liability for the Contest's administration, prizes, or promotion. An entrant is providing entry information to the Station and not to Facebook, Instagram, or X.

- 4. Winner Selection. On or about 5:00pm CT on Mondays during the Contest Period, there are nine (9) Mondays during the Contest Period, the Station will select, in its sole discretion, one (1) winning entry that will be eligible to win the prize. The winner will be chosen based on creativity of the entry and overall entertainment value, in the Station's sole and absolute discretion. Each winning entrant will be contacted using the email address and/or telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within three (3) days of notification or failure to claim the prize within three (3) days of verification as a winner will result in disqualification and forfeiture of the prize.
- Verification of Potential Winner, THE ELIGIBILITY OF ALL POTENTIAL CONTEST WINNERS 5. Winner is responsible for all taxes associated with prize receipt and/or use. Odds of winning a prize depend on a number of factors including the number of eligible entries received during the Contest Period and listeners participating at any given time.

There is no substitution, transfer, or cash equivalent for prizes, except that the Station may, in its sole discretion and to the extent permitted by law, substitute prizes of comparable value or cash. with this Contest, or any prizes awarded, shall be resolved exclusively by the United States District Court or the appropriate state court located in the Station's listening area; (c) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Contest, but in no event attorneys' fees; and (d) under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased.
