## 99.5 THE WOLF'S "TEXAS INDEPENDENCE JAM COUNTRY POP A TOP WINNING WEEK" CONTEST OFFICIAL RULES

The Station will conduct the **99.5 The Wolf's "Texas Independence Jam Country Pop A Top Winning Week"** Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. Caller nine (9), or any other number announced at the time of the cue-to-call, to the Station, as determined by the Station in its sole discretion, will be the winner for that Selection Day after providing the Station the winning listener's name and phone number, subject to verification and compliance with these Contest Rules. All entries may be played on the air. Time Delay Between Overthe-Air Analog Signal and Internet Broadcast: Due to the time delay that exists between the Station's analog over-the-air signal and the Station's online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station's analog over-the-air signal. As a result, the odds of an online listener entering this Contest on-air may be diminished. The approximate retail value ("ARV") of each prize is One Hundred Dollars to Four Hundred Dollars (\$100.00-\$400.00).

- Entry Conditions and Release.
