99.5 THE WOLF'S "GEORGE STRAIT & PARKER MCCOLLUM" TEXT CONTEST OFFICIAL RULES

When the listener hears a song by George Strait and/or Parker McCollum, send a text message with the full title of the song, spelled correctly, to 888-787-1995. All entries must be received by 11:59pm CT on March 22, 2024 to be eligible for a chance to win a prize.
- 5. Each song will be played a minimum of one (1) time during the Contest Period. Entries must be received by the end of the Contest Period to be eligible to participate in the prize drawing. Message and data rates may apply. Station has no responsibility for any fees or charges associated with any text messages entrant sends or receives in connection with the Contest.
