99.5 THE WOLF'S "WHISKEY MYERS WINNING WEEK" CONTEST OFFICIAL RULES

The Station will conduct the **99.5** The Wolf's "Whiskey Myers Winning Week" Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:
