### 99.5 THE WOLF'S "JUSTIN MOORE & RANDY HOUSER WINNING WEEKEND" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained by contacting radio station KPLX-FM ("Station"), 3090 Nowitzki Way, Dallas, TX 75219 during available business hours Monday through Friday, on the Station website www.995thewolf.com, or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the **99.5 The Wolf's "Justin Moore & Randy Houser Winning Weekend"** Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

# 1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

One (1) different keyword will be announced each hour during the Contest Period from 9:00am-9:00pm CT on Saturday and 10:00am-7:00pm CT on Sunday for a total of six (6) different keywords throughout the contest period.

Each keyword will be announced a minimum of two (2) times on Saturday and a minimum of one (1) time on Sunday during the Contest Period, for a minimum of three (3) times throughout the Contest Period.
