99.5 THE WOLF'S "ACM LIFTING LIVES" TEXT CONTEST OFFICIAL RULES

Entrant agrees to receive messages from Station from time to time relating to the Contest, the Station, and any Contest sponsor or prize provider. Limit one (1) entry per person per phone number.
