99.5 THE WOLF'S "CODY JOHNSON WINNING WEEKEND" CONTEST OFFICIAL RULES

The Station will conduct the **99.5 The Wolf's "Cody Johnson Winning Weekend"** Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. One (1) different keyword will be announced each hour during the Contest Period from 9:00am-9:00pm CT on Saturday and 10:00am-7:00pm CT on Sunday for a total of six (6) different keywords throughout the contest period.
