99.5 THE WOLF'S "TURNPIKE TROUBADOURS WINNING WEEK" CONTEST OFFICIAL RULES

- 1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.
