99.5 THE WOLF'S "JORDAN DAVIS WINNING WEEK" CONTEST OFFICIAL RULES

The Station will conduct the **99.5 The Wolf's "Jordan Davis Winning Week"** Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:
