99.5 THE WOLF'S "CLAY WALKER" TEXT CONTEST OFFICIAL RULES

Entrant agrees to receive messages from Station from time to time relating to the Contest, the Station, and any Contest sponsor or prize provider. Limit one (1) entry per person per phone number.

- 4. **Winner Selection.** On or about 10:00am on July 7, 2025, Station will select one (1) potential winner in a random drawing from among all valid entries received by Station during the Contest Period.
