

NEW COUNTRY 96.3 & 99.5 THE WOLF'S "TEXAS TAHOE SUMMER GIVEAWAY" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained by contacting radio station KPLX and KSCS (together, the "Station"), 3090 Nowitzki Way, Dallas, TX 75219 during available business hours Monday through Friday, on the Station website www.995thewolf.com and/or www.newcountry963.com, or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the NEW COUNTRY 96.3 & 99.5 THE WOLF'S "TEXAS TAHOE SUMMER GIVEAWAY" Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. **NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.**
2. **Eligibility.** This Contest is open only to legal U.S. residents of the Station's Designated Market Area ("DMA") as defined by Nielsen Audio, excluding Florida and New York residents, age eighteen (18) years or older at the time of entry with a valid Social Security number. **Void where prohibited by law.** Employees of Station, Radio Metroplex LLC, WBAP-KSCS Assets, LLC, and each of their parent companies, affiliates, related entities and subsidiaries, promotional sponsors, prize providers, advertising agencies, other radio stations serving the Station's DMA, and the immediate family members and household members of all such employees are not eligible to participate. The term "immediate family members" includes spouses, parents and stepparents, siblings and step-siblings, and children and stepchildren. The term "household members" refers to people who share the same residence at least three (3) months out of the year. The Contest is subject to all applicable federal, state and local laws and regulations. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Station's decisions, which are final and binding in all matters related to the Contest. Winning a prize is contingent upon fulfilling all requirements set forth herein.
3. **Contest Period.** The Contest entry period will begin at **6:00am CT on Monday, July 14, 2025, and will run through 6:00pm on Friday, August 8, 2025** (the "Contest Period"). The Station's computer is the official timekeeping device for this Contest.
4. **How to Enter.** Enter "online" as described below to win the qualifying prize and to qualify for the grand prize event participation drawing. Enter at a "remote broadcast" as described below to win the qualifying prize and to qualify for the grand prize event participation drawing.

Online: Listen to either 99.5 The Wolf (KPLX-FM) or New Country 96.3 (KSCS-FM) weekdays, from 7:00am CT through 9:59am CT, 10:00am CT through 2:59pm CT, and 3:00pm CT through 7:00pm CT during the Contest Period. The Station will announce twelve (12) different hourly keywords each day. During the Contest Period, visit www.newcountry963.com or www.995thewolf.com and enter the hourly keyword into the entry form (as well as First and Last Name, Phone Number, Address and Date of Birth) during the Contest Period. All entries must be received by 7:00pm CT on **Friday, August 8, 2025**, to be eligible for the grand prize event participation drawing. **Limit one (1) entry per person per keyword, regardless of how many email addresses a person may possess and use.** Multiple participants are not permitted to share the same email address. Any attempt by any participant to submit more than one (1) entry per keyword by using multiple/different email addresses, identities, registrations and logins, or any other methods will void that entry and the participant may be disqualified. Use of any automated system to participate is prohibited and will result in disqualification. Station is not responsible for lost, late, incomplete, invalid, unintelligible, inappropriate or misdirected registrations, all of which will be disqualified. In the event of a dispute as to any registration, the authorized account holder of the email address used to register will be deemed to be the participant. The "authorized

account holder” is the natural person assigned the telephone number by the wireless carrier or an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. Potential winner may be required to show proof of being the authorized account holder. All entries become the sole and exclusive property of Station and will not be returned. Station reserves the right to contact entrants and all other individuals whose email address is submitted as part of this promotion. No mail-in entries will be accepted.

Remote Broadcast: For a last chance entry, attend our finale remote broadcast conducted by the Stations listed below and complete an entry form. The last chance remote broadcasts will be held at Heritage Park, 217 S Main St, Irving, TX 75060.

Limit one (1) entry per person per remote broadcast. All entries must be received by the deadline stated at the remote broadcast. Winners must be present to win.

5. **Qualifying Prize Winner Selection.**

Online Entry. Each weekday during the Contest Period, each Station will select one (1) qualifying winner per day in a random drawing from among all valid web entries received by each Station during the Contest Period, for a total of twenty (20) qualifying winners (each, a “Qualifying Winner”) per Station (forty (40) Qualifying Winners total) for the entire Contest Period.

Last Chance Remote Entry. Ten (10) Qualifying Winners will be selected through a random drawing at the last chance remote broadcast at Heritage Park, 217 S Main St, Irving, TX 75060 on Sunday, August 17, 2025, from 2pm – 4:30pm. One (1) winner will be selected every fifteen (15) minutes at each of the following times, 2:15pm CT, 2:30pm CT, and 2:45pm CT, 3:00pm CT, 3:15pm CT, 3:30pm CT, and 3:45pm CT, 4:00pm CT, 4:15pm CT, and 4:30pm CT.

Each Qualifying Winner will get a qualifying prize and will be entered into the Grand Prize Event Participation. The qualifying winner must be present to win, as the Grand Prize giveaway will happen directly after this contest.

6. **Grand Prize Winner Selection.**

The grand prize event will take place Sunday, August 17, 2025, at Heritage Park, 217 S Main St, Irving, TX 75060. There will be fifty (50) finalists, as selected in the grand prize event participation drawing, to participate in the grand prize winner selection. Participants must be able to attend the grand prize event, in person. If a participant is unable to attend, he/she may choose someone to represent them in the event for the grand prize winner drawing. Participants will be required to check in with the designated Station staff member, no later than 5:00pm CT on Sunday, August 18, 2025, at Heritage Park. Exact check-in location at Heritage Park to be determined at a later date. The grand prize winner will be determined through a winning key. Each participant will be assigned a number at the beginning of the event (one through fifty). The Station will then match the randomly numbered keys to the matching participant number. In order of one through fifty, each listener will be given the opportunity to try and open the Grand Prize Box with the Winning Key inside. If the designated key does not open the Grand Prize Box, then the corresponding participant will be disqualified from winning the grand prize. This will continue until the participant with the first winning key opens the Grand Prize Box. The winning numbered key will win the grand prize, subject to verification of eligibility and compliance with the terms of these Official Rules.

7. **Verification of Potential Winner.** THE ELIGIBILITY OF ALL POTENTIAL CONTEST WINNERS IS SUBJECT TO VERIFICATION BY STATION WHOSE DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE CONTEST. The potential winner may be notified by email and/or telephone call after the date of random drawing and/or winner determination. The potential winner will be required to sign and return to Station, within three (3) days of the date notice is sent, an affidavit of eligibility and a liability/publicity release (except where prohibited) to claim the prize, if applicable. A winner who returns the affidavit of eligibility and liability/publicity release will be deemed to have accepted the contest prize and thereafter will not be permitted to rescind their acceptance of the prize and/or return the prize. If a potential winner cannot be contacted, fails to sign and return the affidavit of eligibility and/or the liability/publicity release within the required time period (if applicable), or if the prize or prize notification is returned as undeliverable, potential winner forfeits prize. In the event that the potential winner of a prize is disqualified for any reason, Station may award the applicable prize to an alternate winner by random drawing from among all remaining eligible entries. THE APPROXIMATE RETAIL VALUE ("ARV") OF EACH QUALIFYING PRIZE IS ONE HUNDRED DOLLARS (\$100.00). FOR A GRAND TOTAL OF FIVE THOUSAND DOLLARS (\$5,000) IN QUALIFYING PRIZING.

Grand Prize. One (1) grand prize ("Grand Prize") will be awarded in this Contest. The Grand Prize is either (a) one (1) 2025 Chevrolet Tahoe 4WD Z71, color Cypress Gray, all final specifications to be selected in Prize Sponsor's sole discretion or (b) a \$25,000 check as a cash payout – in the winner's discretion.

Station reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Contest or to be acting in violation of these Official Rules or acting in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately undermine the legitimate operation of the Contest may be a violation of criminal and civil law, and, should such an attempt be made, Station reserves the right to seek damages from any such person to the fullest extent

permitted by law. Station's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.

13. **Limitations of Liability.** The Released Parties are not responsible for: (a) any incorrect or inaccurate information, whether caused by Station, entrants, printing errors or by any of the equipment or programming associated with or utilized in the Contest; (b) technical failures of any kind, including but not limited to malfunctions, interruptions, or disconnections in phone lines or network hardware or software; (c) unauthorized human intervention in any part of the entry process or the Contest; (d) technical or human error that may occur in the administration of the Contest or the processing of entries; or (e) any injury or damage to persons or property that may be caused, directly or indirectly, in whole or in part, from entrant's participation in the Contest or receipt or use, non-use or misuse of any prize. No more than the stated number of prizes will be awarded. In event that a production, technical, programming or other error causes more than stated number of prizes as set forth in these Official Rules to be claimed, Station reserves the right to award only the stated number of prizes by a random drawing among all legitimate, unawarded, eligible prize claims.
14. **Disputes.** Entrant agrees that: (a) any and all disputes, claims and causes of action arising out of or connected with this Contest, or any prizes awarded, shall be resolved individually, without resort to any form of class action; (b) any and all disputes, claims and causes of action arising out of or connected with this Contest, or any prizes awarded, shall be resolved exclusively by the United States District Court or the appropriate state court located in the Station's listening area; (c) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Contest, but in no event attorneys' fees; and (d) under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased. SOME JURISDICTIONS DO NOT ALLOW THE LIMITATIONS OR EXCLUSION OF LIABILITY FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE MAY NOT APPLY TO YOU. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of entrant and Station in connection with the Contest, shall be governed by, and construed in accordance with, the laws of the state in which the Station is located, without giving effect to any choice of law or conflict of law rules (whether of the state in which the Station is located or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the state in which the Station is located.
